Now He was telling them a parable to show that at all times they ought to pray and not to lose heart, saying, "In a certain city there was a judge who did not fear God and did not respect man. There was a widow in that city, and she kept coming to him, saying, 'Give me legal protection from my opponent.' For a while he was unwilling; but afterward he said to himself, 'Even though I do not fear God nor respect man, yet because this widow bothers me, I will give her legal protection, otherwise by continually coming she will wear me out.' " And the Lord said, "Hear what the unrighteous judge said; now, will not God bring about justice for His elect who cry to Him day and night, and will He delay long over them? I tell you that He will bring about justice for them quickly. However, when the Son of Man comes, will He find faith on the earth?" — Luke 18:1 — 8 (NASB 1995)

#### 1. The Cry of the Widow

Her disadvantage (vs. 3)

There was a widow in that city ...

Her demand (vs. 3)

"Give me <u>legal protection</u> ..."

Her desperation (vs. 3)

"... from my opponent."



### 2. The Coldness of the Judge

- He was corrupt (vs. 2)
   "In a certain city there was a judge who <u>did not fear God</u> and <u>did not respect man</u>."
- He was calloused (vs. 4)

"For a while he was unwilling; ..."

#### 3. The Contrast with Our Father

- He honors those who pray (vs.7 8)
  - "... now, will not God bring about justice for His elect who cry to Him day and night, and will He delay long over them? I tell you that He will bring about justice for them quickly."
- He hears those who pray (vs. 6)

"Hear what the unrighteous judge said; ..."

# 4. The Challenge to the Church

- Be consistent in prayer (vs. 1)

  "Now He was telling them a parable to show that at all times ..."
- Be committed to prayer (vs.1)
  - "... they ought to pray ..."
- Be comforted by prayer (vs.1)
  - "... and not to lose heart,"
